A tract of land located in Lot 2 (SW/4 NW/4) of Section 31, T16N R9E Creek County described as commencing at the Southwest corner of said Lot 2, thence North a distance of 368.71 feet; to the Northerly right-of-way of State Highway 66, thence North 41 degrees 11' 17" East a distance of 267.58 feet to the true point of beginning; thence North and parallel to the West line of Lot 2 a distance of 441.42 feet, thence North 41 degrees 11' 17" East parallel to the right-of-way of State Highway 66 a distance of 176.63 feet, thence South 38 degrees 38' 25" East a distance of 195.48 feet to the Northerly right-of-way of State Highway 66, thence South 41 degrees 11' 17" West a distance of 456.81 feet to the point of beginning.
