The regularly scheduled meeting of the Bristow City Council was called to order in the Council Chambers of the Municipal Building at 7:00 P.M. A roll call was had with the following members present. Mayor Ralph Barnett. Councilmember: Deloris Carter, Bob Edwards, Frank Groom, Leon Smith, Edgar Spencer, Leonard Washington and Randy Witty. Councilman Absent: Darold Ritchie.

At this time Mayor Ralph Barnett had asked for a moment of silence to honor the victims in the Washington D.C. Navy yard shooting that happened earlier today.

Motion was made by Groom with a second by Witty approving Minutes of the September 3, 2013 Meeting. A roll call was had with the following members present voting as follows: Carter, Aye; Edwards, Aye; Groom, Aye; Smith, Aye; Spencer, Aye; Washington, Aye and Witty, Aye. Motion passed.

Motion was made by Groom with a second by Smith approving to take no action on the Discussion and possible approval of A CNG Station.
