JUNE 24, 2014 SPECIAL MEETING MINUTES

The Special meeting of the Bristow Municipal Authority was called to order in the Council Chambers of the Municipal Building at 5:30 P.M. A roll call was had with the following members present. Chairman Ralph Barnett. Trustees: Deloris Carter, Darold Ritchie, Leon Smith, Edgar Spencer, Leonard Washington and Randy Witty. Absent: Councilman Frank Groom.

Motion was made by Smith with a second by Spencer approving to appoint Kenny Odell to fill the unexpired term of Trustee Bob Edward, Ward 3. A roll call was had with the following members present voting as follows: Carter, Aye; Ritchie, Aye; Smith, Aye; Spencer, Aye and Witty, Aye. Motion passed.

At this time City Clerk Sabrina Mounce gave the Oath of Office and Loyalty Oath to Kenny Odell.

Motion was made by Washington with a second by Ritchie approving a Solid Waste Collection Contract with Green Environmental Services, LLC for the 2014-2021 year. The initial term of this contract shall be for a period of seven (7) years effective July 1, 2014. The contract term may be extended for an additional seven (7) years with the Authority. There were a couple changes to the original contract to read (1) If the price of diesel oil exceeds \$5.00 per gallon, the Authority and Contractor shall negotiate a fuel surcharge to address the additional costs and (2) a free "Roll off dumpster" of one 40 cubic yard per month or 12 per year shall be placed for public access. A roll call was had with the following members present voting as follows: Carter, No; Odell, No; Ritchie, Aye; Smith, No; Spencer, Aye; Washington, Aye; and Witty, Aye. Motion passed.

Mayor Ralph Barnett wanted to think his family, friends, Council and City Employees for everything they have done for him during his time in office.
